3. *The reason no notice is given to the other side Leonard Griffin is a danger to is:* There is Not enough time to keep the Respondent from going back to Cedar Springs and causing further disruption to the Staff. The child's well being.
4. *The harm that cannot be undone if the court does not grant this motion is:* The Child James Griffins Mental treatment at cedar springs be undone and the child be harmed or mentally relapsed.


