ORDER REGARDING SUPERVISED PARENTING TIME AND SPECIAL ADVOCATE	

THIS MATTER came before the court July 29, 2004, for a hearing on the Respondent's Motion for Forthwith Hearing on Parenting Time and Respondent's Motion for Appointment of Special Advocate. The Petitioner, Francis Gale, appeared in person and with her attorney, Robert S. Fisher. The Respondent, Leonard Griffin, appeared in person and with his attorney, J. Tyler Makepeace. The court after having been advised that the parties reached an agreement on all issues, hereby finds the parties' agreement to be fair, conscionable, and in the best interest of the parties and their child, James Griffin. The court also finds that Dr. Mark Hoffman has agreed to serve as a special advocate for James Griffin.

NOW THEREFORE, the court adopts the parties' stipulation and Orders as follows:

1. **Supervised Parenting Time:** The Respondent shall have supervised visits with James by CASA or by any other person recommended by the Special Advocate. The visits shall occur on Fridays and Sundays or at other times deemed appropriate by the Special Advocate.
2. **Special Advocate:** Dr. Mark Hoffman shall be, and the same hereby is, appointed as a special advocate for James Griffin.

- 3. **Payment of the Special Advocate:** The Respondent shall pay the first two thousand dollars (\$2,000.00) to Dr. Hoffman, for his services. The parties shall equally pay for all of the special advocate's fees after the first two thousand dollars.


